

HBF Run for a Reason 2026

Public Volunteer Registration Competition Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for the competition form part of the conditions of entry. Taking part in this competition constitutes acceptance of these terms and conditions.
2. The promoter is HBF Health Limited ABN 11 126 884 786, 570 Wellington St Perth WA 6000, ph. 133423 (**Promoter**).
3. This promotion commences at 5.00 AM WST on Tuesday 3 February 2026 and closes at 4.00 PM WST on Sunday 24 May 2026 (**Promotional Period**)
4. Entry is only open to general public who volunteer for HBF Run for a Reason 2026 during the **Promotional Period** who enter the competition per the entry criteria (**Eligible Entrants**). Directors and employees of HBF Health Limited and its related bodies corporate are ineligible to enter.
5. To enter **Eligible Entrants** must:
 - a. Register to volunteer at the HBF Run for a Reason 2026 event during the Promotional Period and register their attendance as a volunteer at Pack Collection or on event day.
6. There is a limit of one (1) entry per person.
7. The Winners of the competition will be the first two (2) **Eligible Entries** drawn (**Winner**).
